## PARENT COVENANT

1. We/I will read, or have read the Parent/Student Handbook located on the school's website and we/I will abide by it and agree to see that our/my child adheres to it while enrolled at East Richland Christian Schools. We/I also agree to read, or have read, the Statement of Faith and the Statement of Biblical Moral Integrity included in the student enrollment packet and the school's website and will support the school in teaching this doctrine to our/my child throughout their enrollment.
2. We/I grant permission to school authorities to discipline our/my child with the procedures that are outlined in the Parent/Student Handbook. We/I further agree to accept the school's judgment in such matters and will cooperate with them throughout the length of our/my child's enrollment.
3. We/I will pray for the school and staff and endeavor to support the principles, practices and educational policies of the school in every way.
4. We/I agree to attend Parent/Teacher Conferences, contribute at least ten hours of yearly volunteer service for the school, and assist in publicizing the school among our/my friends.
5. We/I recognize that it is essential that our/my child have confidence in his/her teachers and school, therefore, we/I will do all in our/my power to see that our/my child respects and obeys the school staff and rules while enrolled at East Richland Christian Schools. We/I will cooperate in training our/my child to respect church-school property and will correct any willful damage or defacing of such property done by our/my child while a student at East Richland Christian Schools.
6. We/I agree that if our/my child should become involved in any trouble or we/I disagree with any policies set by the school, we/I will in no case complain to any other party, and in the spirit of meekness will register only necessary complaints with the teacher or administrator involved. (Matthew 18:15-17)
7. We/I agree to have our/my child in regular attendance in a Sunday school and church and will strive to provide a consistent example of Godly living in our/my home life.
8. We/I agree to uphold and support the high academic standards of East Richland Christian Schools and will see that our/my child reaches school on time with any necessary slips signed and returned. We/I will provide our/my child with a place to study and will encourage him/her in the completion of any assignment or homework.
9. We/I understand tuition payments may be made in monthly installments from June until May; that any account not paid by the 10<sup>th</sup> of each month will be assessed a \$5 late charge; any payment past due more than 30 days is subject to a \$25 late charge, and student may be asked to disenroll. A charge will be implemented for all returned checks. No grade card or records will be released until all bills are paid.
10. We/I understand that tuition is owed for the entire school year once the academic year begins and is refundable only in cases where a family is moving away from the area and, as a result, is no longer able to attend East Richland Christian Schools. Reimbursement will be pro-rated by the day for those moving away from the area.
11. **(For grades 9-12)** We/I understand that Jesus came to serve and calls His disciples to serve and love others. Therefore, we/I will encourage our/my child to follow Jesus' example by volunteering 60 hours of service per year in accordance with the volunteer service hour program at East Richland Christian High School.
12. We/I have prayerfully read this Parent Covenant and agree to support the covenant by our/my actions and attitudes.
